

George Mason University Summer 2008 Financial Aid Application

PRIORITY FILING DATE APRIL 25,2008

ELIGIBILITY: STUDENTS MUST BE ENROLLED AT LEAST HALF-TIME IN ANY COMBINATION OF SUMMER TERMS (with the exception of students that are applying for Federal Work Study only or have remaining Federal Pell Grant eligibility).

Any student who does not meet the Office of Student Financial Aid's satisfactory academic progress standards will not be eligible.

Due to the processing constraints with Summer Aid, you should plan to have other resources available to pay for your living expenses and books.

-
1. You **must** be **PRE-REGISTERED** for summer courses to be considered for Summer Financial Aid.
 2. You CANNOT receive a Federal Pell Grant simultaneously from two colleges/universities. The Federal Pell Grant funds will be disbursed to George Mason at the end of the ADD/DROP period for the LAST summer session (usually in late July).
 3. **PLEASE NOTE:** Loan funds are generally not released until after your summer courses begin. Refunds from loans are processed by Student Accounts 7-10 days after your loan funds have been received by Mason.
 4. If you are awarded Federal Work-Study for the summer term, you MUST complete the work-study authorization paperwork with the GMU Office of Student Financial Aid and the employer.
 5. If the session(s), which you are enrolled for the summer change, you must notify the Office of Student Financial Aid as soon as possible.
 6. An INCOMPLETE summer aid application WILL BE RETURNED TO YOU.

- If you are applying for a Federal PLUS loan, your parent may also need to complete a PLUS master promissory note, if needed, information will be mailed to your parent's address. You **may** be required to complete a Federal Stafford Loan master promissory note if you have not previously done so. Information about completing your promissory note will be mailed to your permanent home address after you have signed and accepted the loan on your Notification of Award.
- You should be aware that you might not be eligible for loan assistance during the summer if you borrowed the annual maximum amount during the 2007-2008 academic year. Since summer assistance will be limited, students are urged to seek other sources of support.
- Summer award letters will be mailed out starting approximately April 18,2008. Awards CANNOT be made until your summer registration is verified.

You should be prepared to cover tuition, books, and living expenses during this period. The processing time for the summer term is limited.
